**ADDITIONAL INFORMATION**

\*Dues: Based on your actual or estimated year-end revenue from the previous year. Fees earned during the preceding calendar year for abstracting, searching and examination of titles (including all services related thereto), premiums written for insurance and fees earned in escrow, settlement and closing services during said period, plus that portion of the premiums for insurance which is retained by the agent or remitted to it by the insurer. Should any of the fees be earned from an entity which is not a member of the Association but which is part of an affiliated group of companies of which the member is one, or if there is substantial common ownership of such entity and the member, such fees received by the non-member shall be included in establishing gross revenue of the member.

\*\*Agents/Abstracters Members whose actual or estimated income is \$200,000 or less for the previous year are eligible to renew at \$325 for the current ALTA membership year. You must provide a copy of the first two pages of your previous year tax return (1040, 1040A, etc.) to renew at this special rate.

\*\*\*Over \$1,000,000 – Please note: For each additional \$100,000 in gross revenue, add \$175.00 for ALTA membership dues. Maximum dues amount for Abstracter and Agent members is \$17,120. Members who pay \$1,700 or more in dues will receive an invitation to the Title Agents Executive Conference ("Large Agents Forum").
