## Dues Schedule:

1. Determine your gross revenue.

Fees earned during the preceding calendar year for abstracting, searching and examination of titles (including all services related thereto), premiums written for insurance and fees earned in escrow, settlement and closing services during said period, plus that portion of the premiums for insurance which is retained by the agent or remitted to it by the insurer.

Should any of the fees be earned from an entity which is not a member of the Association, but which is part of an affiliated group of companies of which the member is one, or if there is substantial common ownership of such entity and the member, such fees received by the non-member shall be included in establishing gross revenue of the member.

2. Use the chart below to determine your dues payment based on your gross revenue per above.

Over \$1,000,000 -- For each additional \$100,000 in gross revenue, add \$150.00 for ALTA membership dues. Maximum dues amount for Abstracter and Agent members is \$15,000. Note: members who pay \$1,700 or more in dues will receive an invitation to the Title Agents Executive Conference ("Large Agents Forum").

- Only active members of the American Land Title Association (**ALTA**) are eligible to obtain professional liability (E&O) insurance through TIAC.
- The **ALTA** membership year runs from January 1 – December 31 whereas **TIAC** coverage period begins the date the coverage is secured. This means that insured members will receive *separate* renewal notices from **ALTA** and from **TIAC**, at two different times.
- **\*\*Members whose gross revenue was \$200,000 or less in 2021 must provide a copy of the TIAC renewal application including the page confirming your 2021 gross business income or submit a copy of the first two pages of your 2021 tax return to renew at the special \$275 dues rate.**
